### ADDITIONAL FEES

- Non-refundable application fee of \$35.
- Certain courses, athletic teams and field trips may require additional fees.
- Bus fees are in addition to tuition fees. Riding the school bus is optional.
- **A Re-enrollment fee of \$100 is payable each Spring for returning families. This \$100 is then credited to September's tuition.**

### NOTES

- The Federal Government allows parents who choose faith-based schooling for their children to utilize a portion of their tuition fees as a charitable donation for income tax purposes. This amount varies from year to year dependent on the cost of operating the school, the number of students attending, and the revenue received from sources other than tuition, for example, government grants. The calculated cost per student attending King's Christian School is deducted from each student's tuition fees paid, and the remainder qualifies as a charitable donation for tax purposes.
- 1 month notice required for withdrawal.
